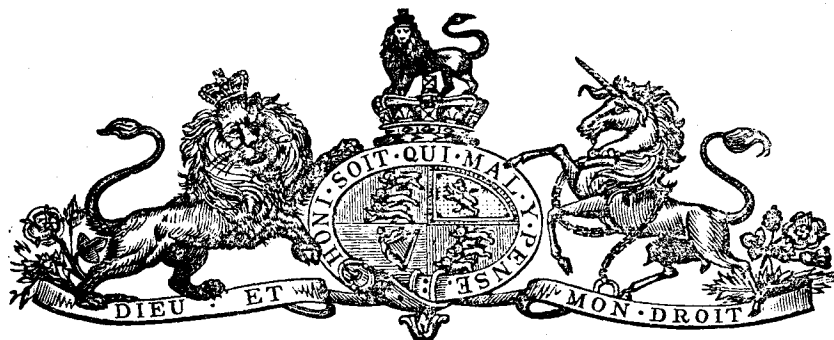

AN ACT to further amend "The Life Assurance Companies Act, 1874." A.D. 1889.  
[9 November, 1889.]

**W**HEREAS it is expedient to further amend "The Life Assurance Companies Act, 1874," in the manner hereinafter appearing: PREAMBLE.  
38 Vict. No. 6.

Be it therefore enacted by His Excellency the Governor of *Tasmania*, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows :—

**1** This Act may be cited as "The Life Assurance Companies Amendment Act, 1889." Short title.

**2** In this Act, "the Principal Act" means "The Life Assurance Companies Act, 1874." Interpretation.

**3** The words "One hundred Pounds" in the 39th Section of the Principal Act shall hereafter be read as Two hundred and fifty Pounds. Amendment of  
S. 39, 38 V. No. 6.

**4** Notwithstanding anything contained in the Principal Act, any Company which has not a Board of Directors or a Committee of Management or other Managing Body in *Tasmania* may be registered under the Principal Act, by lodging in the Office of the Registrar a Memorandum in the form in the Schedule hereto, signed by the Agent or Representative of the Company in *Tasmania*, and verified by a Declaration under "The Statutory Declarations Act, 1837," of the person signing such Memorandum, or by lodging in the Office of the Registrar a Memorandum in the form in the Schedule (1) to the Companies not  
having Board of

*Life Assurance Companies Amendment Act, 1889.*

A.D. 1889.

Principal Act, signed by the Chairman and Principal Officer or Agent managing the Life Assurance business of the Company in another of the Australasian Colonies, and verified by such a Declaration as aforesaid of the persons so signing.

Company to deposit £5000 with Treasurer.

**5** The Registrar shall not issue a Certificate of Registration in respect of any such Company as aforesaid until there shall have been deposited with the Treasurer, on behalf of the Company, the sum of Five thousand Pounds, to be invested by him in such security approved by the Treasurer as the Company or its Agent or Representative may indicate, and the income of such sum as aforesaid shall be receivable by the Company or its Agent or Representative in *Tasmania*.

Penalty for effecting Policy in unregistered Company.

**6** Every person who shall solicit or accept or receive from any person resident in *Tasmania* any proposal to become a policy-holder, or any proposal to effect in any manner an assurance upon the life of any person in *Tasmania*, in any Company not registered under the Principal Act or under this Act, shall be guilty of a Misdemeanour, and being convicted thereof shall be liable, at the discretion of the Court, to be imprisoned for a period not exceeding Three Years, or to forfeit and pay a penalty not exceeding One hundred Pounds.

Acts to be read together.

**7** This Act and the Principal Act, and every Act amending the same, shall, save as amended by this Act, be read and construed together as one Act.
