AN ACT to provide for Loans to certain Local 1918. Bodies by reappropriating portion of the unexpended balance of moneys authorised to be advanced to the St. Helens Water Trust, and for other purposes. [23, December, 1918.]

W HEREAS, by the Act 58 Victoria No. 35, the Governor was PREAMBLE. authorised to grant, in accordance with the provisions of "The Local Public Works Loans Act, 1890," a sum of money not exceeding Two thousand five hundred Pounds as a loan to the trustees of the St. Helens Water District, for the supply of water to the town of St. Helens and contiguous districts:

And whereas, by the Act 58 Victoria No. 40, the Governor was authorised to issue Tasmanian Stock for the purposes (inter alia)

And whereas the Governor has issued such stock:

And whereas, out of the said sum of Two thousand five hundred Pounds, there is a balance of Two thousand four hundred Pounds not now required for the purpose for which it was raised:

And whereas it is desirable that portion of such balance should be

reappropriated for the purposes hereinafter appearing:

Be it therefore enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:—

#### Short title

1 This Act may be cited as "The Loans Reappropriation Act, 1918."

#### Interpretation.

- 2 In the construction of this Act, unless the context otherwise determines—
  - "Treasurer" means the Treasurer of the State of Tasmania for the time being.

Authorising Treasurer to appropriate unexpended balances under First Schedule to purposes of Second Schedule. 3 It shall be lawful for the Treasurer to appropriate any portion of the unexpended balance of the money provided by Parliament for the purpose set forth in the First Schedule hereto, in and towards the several purposes set forth in the Second Schedule hereto.
