

#### ANALYSIS.

1. Short title.

2. Empowering Warden, Councillors, and Electors of Municipality of Longford to surrender 1a. 1r. 32 2/10p. of land to His Majesty the King.

AN ACT to enable the Warden, Councillors, 1918. and Electors of the Municipality of Longford to Surrender a certain Piece of Land to the Crown for the erection thereon of a Hospital, and for other purposes.

W HEREAS in the year One thousand eight hundred and ninety- PREAMBLE, seven, pursuant to the provisions of Sections Twenty-four and Twentyfive of "The Crown Lands Act, 1890," a piece of land, situate in the Town of Longford, Tasmania, containing Three acres and Sixteen perches, be the same a little more or less, was granted to the Warden, Councillors, and Electors of the Municipality of Longford for certain municipal purposes:

And whereas it is now desired that the Warden, Councillors, and Electors of the Municipality of Longford should be empowered to surrender to the Crown One acre One rood Thirty-two perches and Twotenths of a perch, portion of the said piece of land so granted, for the

purpose of having a hospital erected thereon:

## Longford Municipality Enabling.

Be it therefore enacted by His Excellency the Governor of Tasmania. by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows: -

Short title.

1 This Act may be cited as "The Longford Surrender Act, 1918."

Empowering Warden, Councillors, and Electors Longford to surrender la. 1r. 32 2/10p. of land to His Majesty the King.

2 The Warden, Councillors, and Electors of the Municipality of Longford are hereby empowered to surrender to His Majesty the King, of Municipality of and to do all acts, deeds, matters, and things whatsoever necessary to perfect such surrender of, all that piece or parcel of land situate in the Town of Longford, in Tasmania, containing One acre One rood Thirtytwo perches and Two-tenths of a perch, be the same a little more or less, as the same is more particularly described in the schedule to this Act, and delineated in the plan attached thereto, and therein coloured red.

### SCHEDULE.

#### TOWN OF LONGFORD.

la. 1R. 32 2/10P.

Hospital Site.

Bounded on the north-east by 6 chains 18 1/10 links north-westerly along 2a. 3r. 38p. of land granted to Charles Reid and along 1a. 3r. 19p. of land purchased by Charles Reid commencing at the south angle of the firstmentioned land on Archer-street on the north-west by 3 chains 54 9/10 links south-westerly along Smith-street on the south-west by 5 chains 81 1/10 links south-easterly along a passageway to Archev-street aforesaid and thence on the south-east by 1 chain 44½ links north-easterly along that street to the point of commencement.
