

A.D. AN ACT to amend the Matrimonial Causes 1931. Act.

[Reserved, 21st December, 1931; Royal Assent proclaimed, 23rd May, 1932.]

BE it enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows :---

1 This Act may be cited as "The Matrimonial Causes Act, 1931." Short title.

2 The Matrimonial Causes Act is hereby amended by deleting the Amendment of 24 word "four" in the third line of Paragraph 1. of Subsection (2) of Section 14a thereof (inserted therein by the Matrimonial Causes Amendment Act, 1919) and substituting therefor the word "three."

3 The first two recitals of the Matrimonial Causes Act, No. 4, are Repeal of first hereby expunged.

THE LOCAL AUTHORITIES LIGHTING ACT, 1930.

A PROCLAMATION.

W HEREAS by virtue of the provisions of the Local Authorities Lighting Act, 1930, the Governor in Council is empowered, by proclamation, to declare that certain Acts shall cease to have effect and be repealed in certain cases: And whereas the undertaking of the Municipality of Stanley initiated and maintained under the authority of the Stanley Lighting Act, 1924, and the Stanley Lighting Act, 1926, has been taken over by the Hydro-Electric Commission, as provided by the Local Authorities Lighting Act, 1930: Now therefore I, Sir HERBERT NICHOLLS, Knight Commander of the Most Distinguished Order of Saint Michael and Saint George, Lieutenant-Governor of the State of Tasmania and its Dependencies, in the Commonwealth of Australia, by virtue of the powers vested in me by the said Act, do, by this my proclamation, declare that the several Acts enumerated in the schedule hereto shall cease to have effect and shall be repealed as from the publication hereof in the "Gazette."

Given under my hand, at Hobart, in Tasmania aforesaid, this 17th day of April, 1931.
