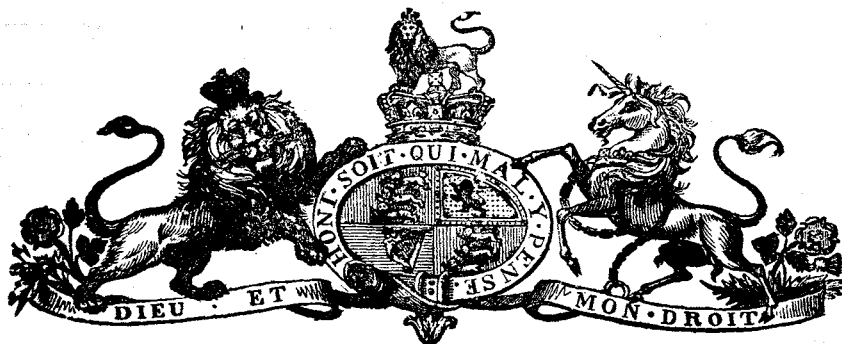

AN ACT to vest the Maintenance of the Bridge A.D. 1873.
across the River *Derwent* at *New Norfolk* in
the Municipal Council of the Rural Municipality of *New Norfolk*. [31 October, 1873.]

BE it enacted by His Excellency the Governor of *Tasmania*, by and PREAMBLE.
with the advice and consent of the Legislative Council and House of
Assembly, in Parliament assembled, as follows :—

1 The control, management, and maintenance of the Bridge across Control, &c. of
the River *Derwent* at *New Norfolk*, are hereby vested in the Municipal Bridge vested in
Council of the Rural Municipality of *New Norfolk*. Municipal Council of New Norfolk.

2 It shall be lawful for the said Municipal Council to repair and Municipal Council may repair, &c.
maintain the said Bridge, and to make, construct, repair, and maintain Bridge and appropriate Municipal
the roadways approaching thereto, in such manner and with such Fund to that purpose.
materials as the said Council may from time to time think proper, and
to appropriate to any such purpose so much of the Municipal Fund as to
the said Council seems meet.

3 It shall be lawful for the said Council, at yearly, half-yearly, or Municipal Council may
such other periods as to such Council may seem necessary, to make and make Rate.
levy a Rate to be paid for repairing and maintaining the said Bridge,
and for making, constructing, repairing, and maintaining the roadways
approaching thereto, and such Rate when received shall form part of the
Municipal Fund ; but such Rate shall not exceed the sum of Threepence
in the Pound in any One year upon the assessed annual value of the
lands and buildings within the said Rural Municipality.

New Norfolk Bridge Act.

A.D. 1873.

Municipal Council may borrow £1000.

4 It shall be lawful for the said Municipal Council to borrow on security of any Municipal Rates, other than the Police and Water Rates, any sums of money not exceeding One thousand Pounds for the purpose of repairing and maintaining the said Bridge, and for making, constructing, repairing, and maintaining the roadways approaching thereto.

If after having borrowed the said sums or any part thereof the said Council pays off the same, it shall be lawful for the Council again to borrow the amount so paid off, and so from time to time; and the provisions of *The Rural Municipalities Act, 1865*, relating to *Loans* shall be applicable to the sums of money borrowed under this Act.

Sect. 100 of 29 Vict. No. 8 to be applicable.

5 All the provisions contained in the One hundredth Section of *The Rural Municipalities Act, 1865*, relating to the preservation and repairing of Bridges, shall be applicable to the Bridge mentioned in this Act.

Toll-gate not to be erected.

6 No Toll-gate or Side-bar shall be erected or placed upon or across the said Bridge by the said Council, nor in, upon, or across any roadway approaching thereto.

7 This Act may be cited as "*The New Norfolk Bridge Act, 1873.*"
