AN ACT to amend The Public Works Act, 1865. [20 February, 1867.]

WHEREAS it is expedient to amend *The Public Works Act*, 1865: PREAMBLE. Be it therefore enacted by His Excellency the Governor of *Tasmania*, 29 Vict. No. 1. by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:-

1 At any time after the commencement of any of the Works to be Governor in constructed under the provisions of The Public Works Act, 1865, Council to make it shall be lawful for the Governor in Council to make Regulations and Regulations. it shall be lawful for the Governor in Council to make Regulations, and, from time to time, to alter or rescind the same-

For regulating the manner in which the Public shall use and enjoy any Works constructed under the authority of the said Act:

For suspending the use thereof for the purpose of alterations or repairs:

For fixing the amount of Fares for the conveyance of passengers, and the Charges for the carriage of animals and goods, upon any Tramway constructed under the authority of said Act:

For fixing the amount of Tolls upon passengers, animals, and vehicles using any Roads or Bridges constructed under the authority of the said Act:

For preventing any damage or injury to any of the Works:

For regulating generally the travelling and traffic upon or along any of the Works, and for the maintenance of good order thereon and along.

Public Works.

Regulations to be published in Gazette.
Gazette to be evidence.

2 Every such Regulation shall be binding in respect of any such work whether complete or incomplete, and shall be published in the *Gazette*, and the production of a copy of the *Gazette* purporting to contain any Regulation made under the provisions of the said Act or this Act shall be received in all Courts as *primâ facie* evidence of such Regulation.

Breach of Regulation.

3 Every person who offends against any such Regulation shall, upon conviction thereof before any Two Justices of the Peace in the manner prescribed by The Magistrates Summary Procedure Act, forfeit and pay a sum not exceeding Fifty Pounds for each offence.

Roads may be proclaimed Cross Roads under 24 Vict. No. 7.

4 The Governor in Council may proclaim any Road or Tramway or part thereof respectively to be a Cross Road within the meaning of *The Cross and Bye Roads Act*, 1860, anything to the contrary in *The Public Works Act*, 1865, notwithstanding.

Section 14 of 29 Vict. No. 1, repealed. Acts to be read together.

5 Section 14 of The Public Works Act, 1865, is hereby repealed.

6 This Act and The Public Works Act, 1865, shall be read and construed together as one and the same Act.

Short Title.

7 In referring to this Act it shall be sufficient to use the expression The Public Works Act, No. 2.
