

AN ACT to provide for the Construction and A.D. 1877. Improvement of certain Roads, and the Erection of certain Bridges, Jetties, and Lines of Electric Telegraph. [11 December, 1877.]

BE it enacted by His Excellency the Governor of *Tasmania*, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:—

1 In this Act—

- "The Minister" means the Minister of Lands and Works for the Interpretation. time being:
- "Bridges" includes all approaches to any Bridge, and any causeways or works used or necessary to give access thereto.
- 2 It shall be lawful for the Minister to cause to be constructed, Minister to cause completed, or improved the several Works mentioned in the Schedule Works to be con- (1), (2), (3), (4), and (5), at a cost for each separate work not exceeding the amounts set forth in the said Schedule respectively.
- 3 All powers by this Act conferred upon the Minister may be Powers may be exercised by him, or by any person acting under his written authority exercised, anying that behalf, anything contained in the Forty-ninth Section of 33 Vict. No. 8, "The Cross and Bye Roads Act, 1870," to the contrary notwithstanding.

Defrayment of cost of Works.

4 The cost of the several Works specified in the Schedule (1), (2), (3), and (4), shall be defrayed out of the moneys to be provided by Parliament for that purpose; and the cost of the Works specified in the Schedule (5) shall be defrayed out of the Consolidated Revenue Fund.

Purchase of land for constructing, &c. Works. 5 For the purpose of constructing and completing the several Works mentioned in the Schedule, the Minister is hereby empowered to purchase and take, in the mode prescribed by *The Lands Clauses Act*, such land as he deems necessary; and, subject to the provisions of this Act, *The Lands Clauses Act* shall be incorporated with this Act; and, for the purposes of such incorporation, the Minister shall be deemed to be the Promoter of the several undertakings.

Entry upon land.

6 Whenever it is intended to take any Land for any of the purposes of this Act, it shall be lawful for the Minister, after Seven days notice served upon the occupier, to enter upon any land and to stake out the same in such manner as the Minister thinks necessary or expedient; and if any person wilfully pulls up, removes, or destroys the stakes or other marks used for the purposes aforesaid, every person so offending shall, for every such offence, incur a penalty not exceeding Fifty Pounds.

Renting land.

7 It shall also be lawful for the Minister to contract and agree with the persons interested in any land for the demise of such land for the purpose of obtaining materials from such land for any of the purposes of this Act.

Timber may be taken from uncultivated land upon making compensation.

8 It shall be lawful for the Minister, after Twenty-one days notice to the owner or occupier, to enter upon any uncultivated land, and to cut down and to carry away all such indigenous Timber as may be required for any of the purposes of this Act, making full compensation for such timber to the owner of the land: but it shall not be lawful for the Minister to cut down any such indigenous timber where it is made to appear to his satisfaction that the same has been, and is intended to be, reserved and used by the owner or occupier of the Land for the purpose of ornament or shelter.

Materials may be taken from land upon making compensation.

9 Where it is deemed necessary to obtain materials for the construction or repair of any of the said Works, or any other of the purposes of this Act, from any land, it shall be lawful for the Minister, after Twenty-one days notice to the owner or occupier, to enter upon such land, and to dig, quarry, and carry away all such materials as may be required for any such purpose, making full compensation to all parties interested for the material taken, and the damage thereby sustained.

Minister to construct gate or slip-rail.

10 Where any such land as is mentioned in the Eighth and Ninth Sectious of this Act is fenced, no entry shall be made upon such fenced land until the Minister has caused a substantial gate or a slip-rail to be constructed, so as to prevent the escape of sheep, cattle, and horses from out of such fenced land.

Power to make drains on adjoining lands. 11 The Minister shall have power to make, cleanse, and keep open all drains or watercourses which he may deem necessary, in and through any land adjoining or near to any road or new line of road.

When new road is constructed old

12 When any new line of road is constructed and completed, or any existing road or any part thereof diverted or altered, the Minister is

hereby empowered to stop up any old line of road, or any part thereof A.D. 1877. which appears to him to be thereby rendered useless, unless such old road may be line of road or such part thereof leads to any lands, house, or place stopped up. which cannot be conveniently approached by such new line of road or any other then existing road, in which case such old line of road, or so much thereof as may be necessary for the access or approach to such lands, house, or place, shall remain as and be a road to the same.

In case any dispute or difference arises as to the propriety of stopping up any such line of road, or any part thereof as aforesaid, the same shall be heard and determined in a summary manner, upon the application of any parties interested therein to the Justices assembled at the next Court of General Sessions which is holden for the District within which such line of road or such part thereof is situate, and such Justices are hereby authorised to hear and determine the same, and such determination shall be final and conclusive upon all parties interested in such line of road, or such part thereof, and all claiming under them.

13 The Minister is hereby empowered to cut down and remove all Timber growing indigenous timber growing or standing within Seventy-five feet of the near roads may be cut down. centre of any road, making good all damage or injury to the fences, hedges, ditches, walls, or any other thing upon the land of the person on which such timber may be growing or standing.

14 The compensation for taking indigenous timber from uncultivated Compensation for land, or materials from any land, for the purposes of this Act, shall be timber and settled by arbitration in the mode prescribed by The Lands Clauses Act be ascertained. in cases of disputed compensation.

15 Where the Minister gives notice of his intention to take land for If compensation any of the purposes of this Act, and the compensation in respect thereof excessive Minister is determined as in cases of disputed compensation, if the Minister deems may give up land. it inexpedient to paythe amount of compensation so determined, he may, within Twenty-one days after notice of the amount of compensation so determined on, withdraw the first-mentioned notice on payment of all the costs of reference and award.

16 Notwithstanding anything in The Lands Clauses Act contained, In estimating in estimating the amount of compensation to be paid to any person for compensation to land taken for any of the purposes of this Act, the arbitrators or umpire shall take into consideration the benefit that is likely to accrue to the owner to be conperson whose land is about to be so taken from the construction of any sidered. Work mentioned in the Schedule, and the arbitrators or umpire, in awarding compensation to be paid for taking such land, shall make such deduction for such benefit as shall be deemed just; and in case it appears to the arbitrators or unipire that the benefit likely to accrue to the person in respect of any such Work is equal to or greater than the loss he will sustain by reason of the taking of his land for such Work, the arbitrators or umpire may award that no compensation is to be paid, and thereupon the same rights shall accrue as if compensation had been awarded and duly paid.

17 Notwithstanding anything to the contrary contained in this or If either party to any other Act, if either party is dissatisfied with the award of the an award is disarbitrators where the sum awarded for compensation exceeds the sum of satisfied therewith One hundred Pounds, and either party desires to have the compensation Supreme Court settled by a Judge of the Supreme Court, and shall, within Ten days after may decide

the making of such award and notice thereof, signify such desire by notice in writing to the other party, then the amount of such compensation shall be ascertained by a Judge of the Supreme Court in such manner as he deems advisable, and subject to such conditions as such Judge sees fit to impose; and such Judge may also in his discretion make any order as to the person by whom the costs of such proceedings shall be borne.

Where the party dissatisfied with the award gives notice to the other party as aforesaid, then such award shall not be made a Rule of Court until such Judge by an order in writing under his hand determines the matter in dispute.

Rules made under Sect. 11 of 36 Vict. No. 19, to be applicable. 18 All rules made or to be made by the Judges of the Supreme Court under the Eleventh Section of "Main Line of Railway Amendment Act, No. 2," shall be applicable to any proceedings taken under the last preceding Section of this Act.

Short Title.

19 This Act may be cited as "The Public Works Construction Act, 1877."
