

A.D. AN ACT to provide for the Execution of 1930. certain Public Works. [24 November, 1930.]

BE it enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows :----

1 This Act may be cited as "The Public Works Execution Act Short title. (No. 2), 1930."

2 It shall be lawful for the Minister to cause to be undertaken, Minister may executed, and carried out the works specified in Schedules (1) and (2) cause works in to this Act at a cost not exceeding in respect of any item so specified schedules to be carried out. the sum set forth in the said schedules in respect thereof.

Allocation of certain moneys authorised by 20 Geo. V. No. 61.

Power for Treasurer to borrow £38,840 17s.

Application of 44 Vict. No. 32 and 45 Vict. No. 31. **3** It shall be lawful for the Minister to expend any part of the moneys authorised to be expended in respect of the Item numbered 626 in the schedule to the Public Works Execution Act, 1929, but not required for the purposes of that item, in respect of the Item numbered 627 in the said schedule.

4 It shall be lawful for the Treasurer to raise, borrow, and receive for the purposes of this Act any sum or sums of money, not exceeding in the whole the sum of Thirty-eight thousand eight hundred and forty Pounds Seventeen Shillings.

5 The provisions of the Public Works Construction Act, 1880, and the Branch Roads Construction Act, 1881, shall extend and apply to the works mentioned in the schedules as fully in all respects as if the said provisions had been incorporated in this Act.

Optional application of 1 Geo. V. No. 11 or 58 Vict. No. 17. 6 At the option of the Minister any land required for the purpose of any public work authorised by this Act may be purchased, acquired, or taken under the Lands Resumption Act, 1910, or the Land Vesting Act, 1894, and, in the event of such option being exercised in respect of either of those Acts for the purposes of such work, the provisions of such Act shall be deemed to be incorporated with this Act, in lieu of the provisions of the Acts mentioned in Section Five hereof.

Amendment of 20 Geo. V. No. 61, Schedule (2). 7 Schedule (2) to the Public Works Execution Act, 1929, is hereby amended by deleting the words "Concrete Wall" in the second line of the Item numbered 648 therein, and substituting therefor the words "New Fence and Alterations to Existing Wall."
