A.D. AN ACT to provide for the Execution of cer- 1926 tain Public Works, and for other purposes. $[30 \ July, 1926.]$

BE it enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:—

- 1 This Act may be cited as "The Public Works Execution Act Short title. (No. 3), 1926."
 - Interpretation. 2 In this Act—
 - "Commissioners" means the Commissioners of the Public Debts Sinking Fund constituted under the Public Debts 45 Vict. No. 15. Sinking Fund Act, 1881:
 - "Schedule" means schedule to this Act.

Minister may cause to be constructed the works specified in Schedules (1) and (2). Provisions of 44 Vict. No. 32 and 45 Vict. No. 31 to be applicable. Land required may be acquired under 1 Geo. V. No. 11 at option of Minister

- 3 It shall be lawful for the Minister to cause to be constructed, executed, completed, and purchased the works and things specified in Schedules (1) and (2) at a cost for each separate work or thing not exceeding the amount set forth in the said schedules in respect thereof.
- 4 The provisions of the Public Works Construction Act, 1880, and the Branch Roads Construction Act, 1881, shall extend and apply to the works mentioned in the schedules as fully in all respects as if the said provisions had been incorporated in this Act.
- 5 Notwithstanding anything contained in this or any other Act, any land required for the purpose of any public work specified in the schedule may, at the option of the Minister, be purchased, acquired, or taken under the Lands Resumption Act, 1910, and in the event of such option being so exercised the provisions of that Act shall accordingly apply, and be deemed to be incorporated with this Act, in lieu of the provisions of the Public Works Construction Act, 1880, and the Branch Roads Construction Act, 1881.

Treasurer authorised to borrow £14,300.

Appropriation

6 It shall be lawful for the Treasurer to borrow, raise, and receive a total sum not exceeding Fourteen thousand three hundred Pounds for the purposes of this Act.

Appropriation of £22 to redeem £450 and of £138 to redeem £13,850.

- **7**—(1) Out of the Consolidated Revenue there shall be paid to the Commissioners—
 - I. The yearly sum of Twenty-two Pounds for the purpose of redeeming the sum of Four hundred and fifty Pounds, part of the abovementioned sum of Fourteen thousand three hundred Pounds, and being the cost of Item 3 in Schedule (2): and
 - II. The yearly sum of One hundred and thirty-eight Pounds for the purpose of redeeming the sum of Thirteen thousand eight hundred and fifty Pounds, being the balance of the abovementioned sum of Fourteen thousand three hundred Pounds.
- (2) The said yearly sums shall be paid from the first day of July, one thousand nine hundred and twenty-seven, and shall be continued until the said respective sums of Four hundred and fifty Pounds and Thirteen thousand eight hundred and fifty Pounds are fully redeemed.
- (3) The said yearly sums shall be paid as the Governor by any warrants under his hand orders and directs, and when received by the Commissioners shall be paid by them into and form part of the Public Debts Sinking Fund, and shall be money at the disposal of the Commissioners for the purposes of the Public Debts Sinking Fund Act, 1881.

The said sums to form part of Public Debts Sinking Fund.

Commissioners may invest moneys.

(4) The Commissioners may invest all or any of the moneys received by them out of the Consolidated Revenue under the provisions of this Act, and the interest or other profit on any such moneys, in such securities as the Governor shall from time to time prescribe as securities in which investments may be made by the Commissioners.
