

BE it enacted by His Excellency the Governor of Tasmania by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows :--

Amendment of Principal Act.

1. By re-numbering Subsections (1), (2), and (3) as (2) (3) and

(4): II. By inserting at the commencement of the said section the following as Subsection (1) thereof :---

"(1) A stallion shall not be used for stud purposes unless a certificate under this Act shall have been issued in respect of such stallion, and is then in force, except on mares the bonå fide property of the owner of the stallion."
