

AN ACT to amend "The Registration of ^{A.D.}1915 Teachers and Schools Act, 1906." [29 January, 1916.]

BE it enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows :—

1 This Act may be cited for all purposes as "The Registration of Teachers and Schools Amendment Act, 1915," and shall be incorporated with and construed as one with "The Registration of Teachers and Schools Act, 1906," hereinafter called the Principal Act, and shall commence on a day to be fixed by the Governor by proclamation.

Registration of Teachers and Schools Amendment.

Amendment of
Section Three of
the Principal Act.

2 Section Three, Subsection Nine, of the Principal Act is amended by omitting from the Second line the word "Four," and substituting therefor the word "Three."

Amendment of
Section Four of
the Principal Act.

3 Section Four, Subsection Three, of the Principal Act is amended by omitting from the Second line the word "January," and substituting therefor the word "March."

Amendment of
Section Five of
the Principal Act.

4 Section Five, Subsection One, of the Principal Act is amended—

- i. By inserting after the word "either" in the Second line the words "as a kindergarten, or":
- ii. By inserting after the word "primary" in the Third line the words "or as an intermediate":
- iii. By omitting the word "Three" in the Fourth line, and substituting therefor the word "more."

Amendment of
Section Eight of
the Principal Act.

5 Section Eight of the Principal Act is amended—

- i. By inserting the word "kindergarten" before the word "sub-primary," in the Third line and in the Fifth line, and by inserting the word "intermediate," after the word "primary," in the Third line and in the Fifth line:
- ii. By inserting after the word "subjects" in the Fourth line the words "or as a teacher with any Two or more of such qualifications":
- iii. By inserting after the word "school" in the Sixth line the words "or school with any Two or more of such departments."

Amendment of
Section Ten of
the Principal Act.

6 Section Ten of the Principal Act is amended—

- i. By omitting from the Fourth and Fifth lines the words "Section One of the Act of the Parliament of Tasmania, 52 Victoria No. 26," and substituting therefor the following:—"Sections Fourteen, Fifteen, and Eighteen of 'The Evidence Act, 1910'":
- ii. By omitting from the Eighth line the words "One and Two" and substituting therefor the following:—"Sections Fourteen to Eighteen."

Power to conduct
examinations and
charge fees.

7 Any person applying for registration may be required by the Board to pass a prescribed examination, and it shall be lawful for the Board to employ examiners to conduct such examination, and to prescribe a fee not exceeding Ten Shillings to be paid by the applicant to the Registrar before the applicant shall be permitted to sit for such examination, and such fee shall be applied by the Board for defraying the expenses of carrying out this Act.

Amendment of
Section Fifteen of
the Principal Act.

8 Section Fifteen, Subsection One, of the Principal Act is amended—

- i. By inserting before the word "sub-primary" in the Eleventh line the words "kindergarten schools":
- ii. By inserting after the words "primary schools" in the Eleventh line the words "intermediate schools."

Registration of Teachers and Schools Amendment.

9 Section Eighteen of the Principal Act is repealed and the following substituted in its place—

“18 (1)—With the application for registration of a teacher or school not previously registered, there shall be deposited with the Registrar a fee of Five Shillings.

(2) No fee shall be required for the registration of additional qualifications or status for a teacher or school previously registered.

(3) If any application for registration be refused by the Board such fee shall be returned to the applicant.

(4) With the exception specified in the preceding subsection all fees received by the Registrar under the provisions of this Act shall be applied by the Board for defraying the expenses of carrying out this Act.

10 Schedules (1. and (2) are amended by inserting the word “Kindergarten” before “Sub-Primary,” and by inserting the word “Intermediate” after “Primary.”
