# AN ACT to further amend The Real Property Act. <br> [11 October, 1867.] 

BE it enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows :-

1 The Fees in the Schedule shall be taken by the Recorder of Titles, Fees in lieu of and carried to the General Revenue, in lieu of those now payable to the those now payable General Revenue.

2 This Act and The Real Property Act, and The Real Property Acts to be deemed Act, $\boldsymbol{N}_{o} .2$, save so far as the same are altered by this Act, shall be one. deemed one Act.

3 This Act may be cited as "The Real Property Act, No. 3." Short Title.
