

AN ACT to amend "The Railway Service 1923. Appeal Board Act, 1917." [12 April, 1923.]

BE it enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:—

1—(1) This Act may be cited as "The Railway Service Appeal Short title. Board Act, 1923."

(2) "The Railway Service Appeal Board Act, 1917," is herein called Principal Act.

Amendment of Section 9 of the Principal Act.

- 2 Section Nine of the Principal Act is hereby amended as follows:---
 - By deleting the word "Five" in the First line of Paragraph II. of Subsection (1), and substituting the word "Seven" therefor:
 - II. By expunging Paragraphs III. and IV. of Subsection (2), and substituting the following paragraphs therefor:—
 - "III. The 'Running Staff' of the Locomotive Branch shall be deemed to be a separate branch:
 - "iv. The 'Locomotive, Carriage, and Wagon Staff' (excepting thereout the Ironworkers) of the Locomotive Branch shall be deemed to be a separate branch:"
 - III. By inserting the following paragraphs after Paragraph IV. of Subsection (2):—
 - "v. The 'Ironworkers of the Locomotive, Carriage, and Wagon Staff' of the Locomotive Branch shall be deemed to be a separate branch:
 - "vi. The 'Clerical Staff (generally)' shall be deemed to be a separate branch: and
 - "vii. The 'Station Masters' shall be deemed to be a separatebranch, instead of being attached to the Traffic Branch or the Clerical Staff (generally):"
 - iv. By repealing Subsection (3), and substituting the following subsection therefor:-
 - "(3) The Seven employees' representatives shall be elected respectively by ballot in the prescribed manner by the respective employees in, or attached as aforesaid to, the Maintenance Branch, the Locomotive Branch (Running Staff), the Locomotive Branch (Locomotive, Carriage, and Wagon Staff, excepting Ironworkers), the Locomotive Branch (Ironworkers, Locomotive, Carriage, and Wagon Staff), the Traffic Branch, the Clerical Staff (generally) Branch, and the Station Masters' Branch."

- 3 Section Ten of the Principal Act is hereby repealed and the following section substituted therefor:—
 - "10 Th Governor may appoint a secretary to the Board."
- 4 Section Eleven of the Principal Act is hereby repealed and the following section substituted therefor:—
- "11—(1) An election of employees' representatives shall be held in the month of May in the year One thousand nine hundred and twenty-three, and the persons then elected shall, subject to the provisions hereinafter contained, hold office as members of the Board from the First day of June in the lastmentioned year until the Thirty-first day of December, One thousand nine hundred and twenty-five.

(2) An election of employees' representatives shall be held in the month of December, in the year One thousand nine hundred and Elections in 1925 twenty-five, and in the month of December in every Third year there- and subsequent after, and the persons elected at any such election shall, subject to the years. provisions hereinafter contained, hold office as members of the Board for Three years from the First day of January immediately succeeding such election."

5 Notwithstanding anything contained in the Principal Act or this Members in office Act to the contrary, the number of elected members of the Board shall on 1st January, continue to be Five only until the election to be held in the month of 31st May in May, One thousand nine hundred and twenty three, and the persons that year. holding office as such elected members on the First day of January in the lastmentioned year shall, subject to the provisions of Section Fourteen of the Principal Act, continue to hold office as such members until the Thirty-first day of May in that year, when they shall retire from office.
