A.D. AN ACT to provide for the Execution of 1927. certain State Railway Works, and for other [2 December, 1927.] purposes.

BE it enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:—

- 1 This Act may be cited as "The Railway Works Execution Short title. Act, 1927."
- 2 It shall be lawful for the Minister to cause to be undertaken, con- Minister may structed, improved, executed, completed, carried out, purchased, cause works to be acquired, and provided, the various undertakings, works, objects, purposes, land, rolling-stock, and things mentioned in Schedules (1) and (2) to this Act, at a cost therefor not exceeding in each case the amount for the same set forth in the said schedules.

Cost, how to be defrayed.

- 3 The cost of undertaking, constructing, improving, executing, completing, carrying out, purchasing, acquiring, and providing, such undertakings, works, objects, purposes, land, rolling-stock, and things shall be defrayed as follows:—
 - 1. As to the sum of One thousand three hundred and eighteen Pounds One Shilling and Ten Pence, part thereof, by the expenditure of the aggregate of the several sums mentioned in Schedule (3) to this Act (being the amounts, or unexpended balances of the amounts, appropriated for the several items mentioned in the said schedule), which said several sums it shall be lawful for the Treasurer to appropriate and spend accordingly: and
 - 11. As to the sum of Thirty thousand eight hundred and thirty Pounds One Shilling and Eleven Pence, balance thereof, out of moneys provided by this Act.

Act partly retrospective.

4 The provisions of this Act, so far as the same apply to the rolling-stock, undertakings, and purposes mentioned in Schedule (1) to this Act shall have a retrospective operation.

Treasurer authorised to borrow £30,830 1s. 11d.

5 It shall be lawful for the Treasurer to raise, borrow, and receive a total sum not exceeding Thirty thousand eight hundred and thirty Pounds One Shilling and Eleven Pence for the purposes of this Act.
