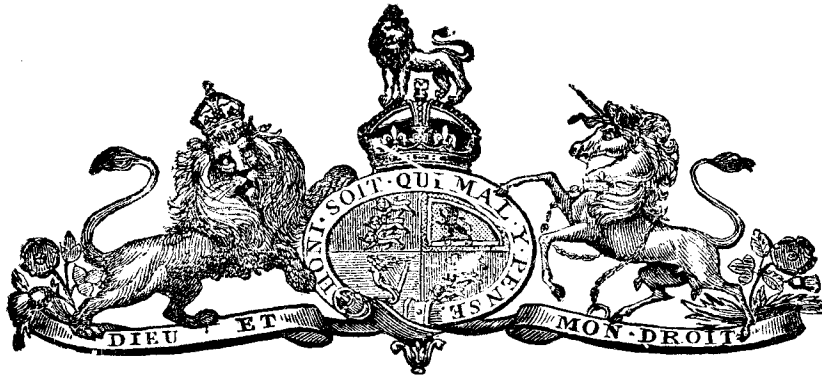

AN ACT to provide for the Execution of ^{A.D.} 1930
 certain Works in Connection with the State
 Railways. [6 December, 1930.]

BE it enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:—

1 This Act may be cited as “The Railway Works Execution Short title. Act, 1930.”

Railway Works Execution.

A.D. 1930.

Minister may
cause works to be
constructed, &c.

2 It shall be lawful for the Minister to cause to be undertaken, executed, and constructed the respective works and things specified in Schedules (1) and (2), at a cost not exceeding in each case the amount set forth in the schedules in respect thereof.

Reappropriation
of moneys.

3 It shall be lawful for the Treasurer to reappropriate the several sums specified in Schedule (3), being the unexpended balances of the amounts appropriated for the several items mentioned in that schedule, and to apply the aggregate thereof, amounting to the sum of One thousand five hundred and fifty-seven Pounds, in defraying the cost of the works authorised by this Act.

Act partly
retrospective.

4 The provisions of this Act, so far as the same apply to the works specified in Schedule (1), shall have a retrospective operation.

Interest on
capital moneys.

5—(1) The interest to be debited from time to time in respect of all capital moneys expended in relation to the State railways shall be at such rate per centum per annum as shall be determined from time to time by the Governor.

(2) This section shall have effect as from the first day of July, one thousand nine hundred and thirty.
