

AN ACT to apply out of the Consolidated Revenue Fund a Sum for the Service of the Year ending the Thirtieth day of *June*, 1908. A.D.
1907.

[12 July, 1907.]

BE it enacted by His Excellency the Governor of *Tasmania*, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:—

1 This Act may be cited as “The Supply Act (No. 1), 1907-8.” Short title.

2 There shall and may be issued and applied towards making good the supply hereby granted to His Majesty for the Service of the year ending the Thirtieth day of *June*, One thousand nine hundred and eight, the sum of One hundred and fifty thousand seven hundred and eighty-three Pounds out of the Consolidated Revenue, for the purposes and services expressed in the Schedule to this Act, and the Treasurer of *Tasmania* is hereby authorised and empowered to issue and apply the moneys authorised to be issued and applied, Issue and application of £150,783.

Supply (No. 1).

A.D. 1907.

Sum available for the purposes set forth in Schedule.

Credit to be given to the Treasurer in Accounts.

3 The said sum shall be available to satisfy the Warrants under the hand of the Governor in respect of any purposes and services set forth in the said Schedule.

4 The said Treasurer shall be allowed credit in his Accounts for any sums of money paid by him in pursuance of any such Warrant as aforesaid; and the receipts of the respective persons to whom the same are so paid shall be a full and valid discharge to the said Treasurer in passing his said Accounts for any such sums as are therein mentioned, and he shall receive credit for the same accordingly.
