

AN ACT to provide for the Execution of certain State Hydro-Electric Works, and for other purposes. [30 January, 1922]

BE it enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:—

1 This Act may be cited for all purposes as "The State Hydro-Short utle. Electric Works Execution Act, 1921."

State Hydro-Electric Works Execution.

Interpretation.

2 In this Act, unless the context otherwise requires—

- "Minister" means the Minister of the Crown to whom the administration of "The Complex Ores Act, 1909," and the Acts incorporated therewith is for the time being committed by the Governor:
- "Treasurer" means the Treasurer for the time being of the State of Tasmania.

Minister to cause works to be constructed, &c.

3—(1) It shall be lawful for the Minister to cause to be undertaken, constructed, improved, executed, completed, and carried out the various undertakings, works, objects, and purposes mentioned in the Schedule to this Act at a cost therefor not exceeding in each case the amount for the same set forth in the said Schedule.

Provisions in 5 Geo. V. No. 4 and Complex Ores Acts to be applicable.

(2) All the powers and authorities vested in or exercisable by the Minister under or by virtue of Section Eleven of "The Hydro-Electric Purchase Act, 1914," or under "The Complex Ores Act, 1909," and the amendments to such Acts, in relation to the construction, execution, or completion of the Hydro-Electric Works referred to in Section Eleven aforesaid, shall extend and apply to the undertakings, works, objects, and purposes mentioned in the Schedule to this Act, and the undertaking, constructing, improving, executing, completing, and carrying out thereof.

Cost how to be defrayed.

4 The cost of the undertaking, constructing, improving, executing, completing, and carrying out the various undertakings, works, objects, and purposes mentioned in the Schedule to this Act, shall be defrayed as follows:—

11 Geo. V. No. 44, 1. As to the sum of Two hundred thousand Pounds, part thereof, out of moneys raised and received by the Treasurer under "The Loans Act (No. 3), 1920-21," which said sum it shall be lawful for the Treasurer to appropriate and expend accordingly:

As to the sum of Twenty-five thousand four hundred and seventy-one Pounds Five Shillings and Eleven Pence, other part thereof, out of moneys raised and received by the Treasurer under "The Closer Settlement Act, 1913," as amended by "The Closer Settlement Act, 1920," which said sum it shall be lawful for the Treasurer to appropriate and expend accordingly:

III. As to the sum of One hundred and nineteen thousand one hundred and forty-two Pounds and Tenpence, other part thereof, out of moneys raised and received by the Treasurer under "The Loans Act (No. 1) 1921-22":

iv. As to the sum of Four hundred and three thousand two two hundred and thirty-three Pounds Eighteen Shillings and Twopence, other part thereof, out of moneys to be appropriated by Parliament for that purpose: and

- v. As to the sum of One hundred and eighty-two thousand four hundred and two Pounds Fifteen Shillings and One Penny, balance thereof, out of moneys to be provided by Parliament for that purpose.
