purchase and supply to Sheffield of electrical energy, in bulk, and to carry out the necessary works required in connection therewith, in accordance with the provisions of the Local Government Amendment Act, 1924 :

Be it therefore enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows :-

1 This Act is divided into three parts, as follows:--
i. Preliminary.

iii. Poll.

## PART I.

PRELIMINARY
2 This Act may be rited as "The Sheffield Lighting Act, 1925," and shall be read as part of, and deemed to be incorporated with, the Local Government Act, 1906.

3 This Act shall commence and take effect on a day to be appointed by proclamation.

4 In this Act and in any by-laws or rules made, unless the context otherwise determines:-
"Council" means the Municipal Council of the Municipality of Kentish:
"Elector" means every person, being a natural-born or naturalized subject of His Majesty, and whether male or female, of or above the age of 'Twenty-one years, whose name as owner or occupier of any property within the light district appears on the Assessment Roll :
"Electrical Energy" means and includes electrical current and electrical power .
"Corporation" means the Warden, councillors, and electors of the Municipality of Kentish.

## PART II.

POWER TO BORROW.
Power to borrow. 5 It shall be lawful for the Council on behalf of the Corporation to raise by way of loan, under the provisions of the State Loans to Local Bodies Act, 1921, any sum or sums of money, not exceeding in the whole the sum of Two thousand two hundred and fifty Pounds, for the purpuse of defraying the cost of the works necessary for the distribution of electrical energy in accordance with the provisions of the Local Government Amendment Act, 1924.

## Sheffield Lighting.

6 The amount payable by the Council as an annual contribution towards a sinking fund in respect of any money borrowed under this Act shall be an amount equal to Two Ponds Five Shillings per centum of the moneys so borrowed.

7 It shall be lawful for the Treasurer of the State of Tasmania to Treasurer borrow, raise, and receive a total sum of Two thousand two hundred and fifty Pounds for the purpose of this Act.

## PART III.

POLL.
8 Before any money is borrowed under this Act the Council shall Poll of elcetors take a poll of electors in the power area in accordance with the to be taken. provisions of the State Loans to Local Bodies Act, 1921, and a majority of the valid votes polled being in the affirmative shall be deemed to be sufficient for the purpose of this Act.
