

2. Authorisation of payment of travelling allowances in certain cases.

AN ACT to enable Members of Parliament to act as Members of the Transport Advisory Committee in certain cases.

W HEREAS the Governor has deemed it expedient to con- PREAMBLE stitute and set up a Committee called the Transport Advisory Committee to advise him upon matters relating to transport:

And whereas it is desirable to enable Members of Parliament to act as members of such Committee in certain cases and to authorise the payment to them of travelling allowances for the purposes of their duties as members of such Committee:

Transport Advisory Committee.

Be it therefore enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:—

Short title.

1 This Act may be cited as "The Transport Advisory Committee Act, 1929.'

Authorisation of payment of travelling allowances in certain cases.

2-(1) In any case where the Governor, on the recommendation or at the request of the Municipal Association of Tasmania, has appointed any person as a member of the Transport Advisory Committee, the payment to, and acceptance by, such person of a travelling allowance shall be lawful, although such person may be a Member of either House of Parliament.

(2) Such allowance as aforesaid shall be paid only in respect of the journeys and attendances of such person on the performance of his duties as a member of such Committee, and shall not exceed such amount as the Governor may determine to be reasonably necessary to provide for the expenses incurred by such person in or about the performance of such duties.

(3) The payment and acceptance of such allowance as aforesaid shall not constitute his membership of such Committee an office of profit or emolument within the meaning of the 18 Vict. No. 17, Constitution Act, nor shall such person be subject to any disqualification, disability, or penalty under, or in relation to, that Act by reason of his acceptance or holding of such office.
