## A BILL

for the validation of certain Orders made under Part II of the *Local Government Act 1958* and for other purposes.

### **Local Government (Validation) Act 1988**

The Parliament of Victoria enacts as follows:

**Purpose.**

1. The purpose of this Act is to validate certain Orders made under Part II of the *Local Government Act 1958* and for certain other purposes.

5 **Commencement.**

2. This Act comes into operation on the day on which it receives the Royal Assent.

**Validation of Orders in Council.**

10 3. (1) An Order made by the Governor in Council under Part II of the *Local Government Act 1958* in relation to a municipality referred to in column 1 of an item in the Schedule and published in the *Government Gazette* on the date referred to in column 3 of that item shall be deemed to have taken effect in accordance with that Part on the date referred to in column 4 of that item and thereafter always to  
15 have been valid.

(2) Any election for councillors of a municipality referred to in an item in the Schedule, and any thing done by or in relation to that

municipality or its Council or persons acting as its councillors or otherwise affecting that municipality, on or after the date on which the Order referred to in that item took effect shall be deemed to have been as validly held or done as it would have been if sub-section (1) had been in force on that date. 5

(3) If an Order referred to in sub-section (1) has been rectified by a subsequent Order in accordance with section 28 (5) of the *Local Government Act 1958*, the reference to that Order is a reference to that Order as so rectified.

#### **Shire of Kyneton.**

4. (1) The election for councillors of the Shire of Kyneton held on 6 August 1988, and any thing done by or in relation to that Shire or its Council or persons acting as its councillors on or after that date, shall be deemed to be as valid as it would have been if the Order of the Governor in Council relating to that Shire published in the *Government Gazette* on 31 May 1988 had taken effect in accordance with Part II of the *Local Government Act 1958* on that date and had been valid. 15

(2) The Governor in Council may, by an Order or Orders published in the *Government Gazette*, provide for an election of all councillors of the Shire of Kyneton on a Saturday specified in the Order, being a Saturday before 31 December 1988. 20

(3) An Order under sub-section (2) may make provision, having regard to the provisions of the *Local Government Act 1958* and the regulations made under section 149 of that Act dealing with enrolment for and voting at municipal council elections, the election of councillors and polls of voters, and any other matter expedient to be provided in relation to the election. 25

(4) Section 28 of the *Local Government Act 1958* applies (with any necessary modifications) in relation to an Order under sub-section (2).

(5) The ridings and the boundaries of the ridings applicable for the purposes of the election referred to in sub-section (2) are the ridings and the boundaries existing before the making of the Order referred to in sub-section (1). 30

(6) For the purposes of the election referred to in sub-section (2), the entitlement date within the meaning of Part IIA of the *Constitution Act 1975* is 15 July 1988. 35

#### **Shires of Colac and Dimboola.**

5. (1) The reference in section 3 to the Order made by the Governor in Council in relation to the Shire of Colac is a reference to that Order as if the boundaries of Ondit Riding and Murray Riding were the boundaries described in the Order made by the Governor in Council on 27 September 1988 and published in the *Government Gazette* on 28 September 1988. 40

(2) The reference in section 3 to the Order made by the Governor in Council in relation to the Shire of Dimboola is a reference to that Order as if the reference in clause 4 of the Order to the Shire of Dimboola were a reference to the South, Centre and West Ridings.
