National Parks (Amendment) Bill

EXPLANATORY MEMORANDUM

Outline

The purposes of this Bill are to establish new parks, to enlarge and vary the boundaries of existing parks and to amend the *National Parks Act* 1975.

Notes on Clauses

Clause 1 outlines the purposes of the Act.

Clause 2 provides for the Act to come into operation on the 28th day after the day on which it received the Royal Assent excepting certain sections dealing with new parks and major additions which come into operation on a day or days to be proclaimed.

Clause 3 names the National Parks Act 1975 as the Principal Act.

Clause 4 provides for new and enlarged parks, as follows:

Sub-clauses (10), (11) and (12) are the usual machinery clauses to close certain unused roads and to revoke areas of reserved forests to be included in the parks.

Sub-clause (13) is a provision required in connection with land dealings for an area to be included in the Warby Range State Park.

Sub-clause (14) is a provision relating to a road reserve omitted from the new description of Pink Lakes State Park.

Clause 5 amends section 25B (1) of the Principal Act, adding to the list of parks from which forest produce may be taken in accordance with the Schedule. The parks in question are—

Clause 6 updates section 31 of the Principal Act for metric conversion, and inserts a new sub-section providing for rights of access by abutting land owners over French Island State Park.

Clause 7 corrects an error in the Principal Act.

The Schedule Parts A and B provide for changes to the Schedules to the Principal Act. Part C describes land to be added to Warby Range State Park when dealings are completed.
