AN ACT to amend the Prisons Act 1903-1962.

[Assented to 13th November, 1963.]

BE it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and the Legislative Assembly of Western Australia, in this present Parliament assembled, and by the authority of the same, as follows:—

Short title
and citation.

1. (1) This Act may be cited as the *Prisons Act Amendment Act, 1963.*

(2) In this Act the Prisons Act, 1903-1962, is referred to as the principal Act.

(3) The principal Act as amended by this Act may be cited as the Prisons Act, 1903-1963.

2. This Act shall come into operation on the day on which Part II. of the Offenders Probation and Parole Act, 1963, comes into operation. Commence-
ment.

3. Section two of the principal Act is amended by inserting after the passage, "PART VIA.—REFORMATORY PRISONS, s.s. 64A-64N" in line fourteen, the following passage— S. 2 am.

PART VIB.—INSTITUTIONS FOR THE RECEPTION
OF CONVICTED INEBRIATES, ss. 64O-64Q.

4. Section four of the principal Act is amended by adding after the interpretation, "Sheriff", the following interpretation— S. 4 am.

"the Board" means the Parole Board established
under the Offenders Probation and Parole
Act, 1963. .

5. Subsection (2) of section thirty-four of the principal Act is amended by adding after the word, "sentence" in line two, the words, "earned under the regulations or regulations made under any other Act". S. 34 am.

6. Paragraph (6) of section thirty-six of the principal Act is amended by adding after the word, "earned" in line two, the words, "under the regulations or regulations made under any other Act". S. 36 am.

7. Subsection (1) of section sixty-four B of the principal Act is amended by substituting for the words, "the Indeterminate Sentences Board appointed as hereinafter provided" in lines five, six and seven, the words, "the Board". S. 64B am.

8. Subsection (1) of section sixty-four C of the principal Act is amended by substituting for the words, "the Indeterminate Sentences Board", in lines two and three, the words, "the Board". S. 64C am.

pealed.

9. Section sixty-four E of the principal Act is repealed.

S. 64F am.

10. Subsection (6) of section sixty-four F of the principal Act is amended by substituting for the word, "probation" in line three and again in lines five and six, the word, "parole".

S. 64G re-
pealed.

11. Section sixty-four G of the principal Act is repealed.

S. 64H re-
pealed.

12. Section sixty-four H of the principal Act is repealed.

13. Subsection (1) of section sixty-four J of the principal Act is amended by substituting for the words, "The Indeterminate Sentences Board", in line one, the words, "The Board".

S. 64K am.

14. Subsection (1) of section sixty-four K of the principal Act is amended by substituting for the words, "the Indeterminate Sentences Board", in line one, the words, "the Board".

S. 64M am.

15. Paragraph (i) of section sixty-four M of the principal Act is repealed.
